#### **GOVERNANCE & NOMINATING**

### Responsibilities

- Identify and nominate strong candidates for the Board
- Assess Board performance and propose updates when appropriate
- Lead strategic planning
- Succession planning and care for the staff executive
- Create and execute organizational policies outside the prevue of staff-level decisions
